## **Travel Expenses & Accommodations**

Transportation, up to and including airfare and overnight accommodations are required for all events. Standard mileage reimbursement based upon the current IRS rate at the time of travel will be used for any mileage. (Note for planning purposes: Chris Gleason's "home airport" is Dane County Regional Airport in Madison, WI "MSN").

Meal reimbursement for all meals from the point of departure to return is also required.

## **Deposit & Cancellation Policy**

A deposit of 50% of the agreed fee is required upon confirmation of the booking. The remaining 50% of the agreed fee is due and payable at least 30 days prior to the event. Applicable expenses will be invoiced immediately following completion of the event.

In the event of cancellation, due to an Act of God or dangerous situation which prevents the event from occurring, the parties may mutually agree to reschedule the event with the same terms as stated in the initial agreement. If the organization cancels the scheduled event and provides notice to the speaker at least 60 days prior to the event, 100% of the initial deposit will be refunded within 30 days of notice of cancellation. If notice of cancellation is given 59 days or less prior to the event, the Organization is responsible for reimbursing the Speaker for any airfare expense and/or other associated travel fees incurred, and forgoes their deposit. If the Speaker attends the event and does not speak due to event schedule conflicts then full payment will still be required.

In the event of an emergency situation (i.e., personal/family-related illness, accident, death, other) that causes Chris Gleason to cancel, the Organization may find a replacement speaker for the speaking engagement, or the engagement will be rescheduled. If the engagement is cancelled because of the emergency situation, the Organization will not be responsible for expense reimbursements and will be reimbursed the deposit fee.
